MAINTENANCE GRAVEL - Furnish and deliver approximately 8,000 cubic yards of Processed Road Gravel (22-A Modified) at Road Commission Yards at Fennville, Diamond Springs, Allegan, and Shelbyville.

> The material in the amount shown is to be furnished and delivered at each of the Four (4) County yards listed. These unit bid prices shall be guaranteed until December 31, 2015, for delivery of additional road gravel to any of these four (4) yards, should additional quantities be needed.
