The undersigned further proposes to do such extra work as may be ordered by you, prices for which are not included in the itemized bid, compensation therefor to be made on the basis agreed upon before such extra work is begun.

No bid bond is required.

The term of this contract is for 2020. This contract may also be extended for three additional one-year periods upon mutual agreement of both parties.

In case the bidder is a co-partnership, each member must sign this proposal. In case the bidder is a Corporation, this proposal must be executed by its duly authorized officials in accordance with its articles of incorporation and a certified copy of such articles must be attached hereto.

We hereby offer our bid for furnishing and delivering processed road gravel as follows:

MAINTENANCE GRAVEL -

Furnish and deliver approximately 4,000 cubic yards of Processed Road Gravel (22-A Modified) at Road Commission Yards at Fennville and Diamond Springs.

The material in the amount shown is to be furnished and delivered at each of the Two (2) County yards listed. These unit bid prices shall be guaranteed until December 31, 2019, for delivery of additional road gravel to any of these two (2) yards, should additional quantities be needed.

The gravel shall meet 2012 Michigan Department of Transportation Specifications 22-A as modified.
