We hereby offer our bid for sand for use as an ice control material for the 2022-2023 Winter Season. The unit prices as listed are based on the following conditions and requirements:

1. Truck Delivery - F.O.B. Road Commission Garage at the location shown.
2. Half of the material to be delivered to each location within 30 Days of award of contract, the other ½ by December 31, 2022.
3. All material to meet MDOT Spec. for 2NS (Modified) and must be tested by the ACRC before delivery.
4. Bid prices shall remain unchanged for the entire season, irrespective of actual quantities. Additional quantities shall be delivered within one week of order.
5. Award for each location may be made separately based on what is in the best interest of the ACRC.
