The bid price is per mowing, which shall normally be weekly for the 20-mowing minimum of the Administration Facility and bi-weekly for the 10-mowing minimum for the outside locations, or as directed for special needs or the other facilities.

All designated areas shall be mowed 2 ½” to 3” above ground.

The bid amount is per mowing of each designated location.

All objects within or bordering the mowed areas shall be trimmed.

The contractor shall personally investigate field conditions prior to each mowing. Failure on the part of the Contractor to investigate or inspect will not be grounds for additional compensation.

The order of mowing locations will be at the direction of the Road Commission.

The bid prices are to remain firm through November 30, 2023.

Contract Extension – This contract may be extended one year at a time for three years by mutual written agreement of both parties. Request for extension should be submitted no later than April 1, by the contract to be considered.

NOTE: *This bid price includes all service, destination and delivery charges and constitutes the complete and total amount of the bid. No other charges will be allowed.

If anything in the other Contract Documents is inconsistent with this Agreement, this Agreement shall govern.
